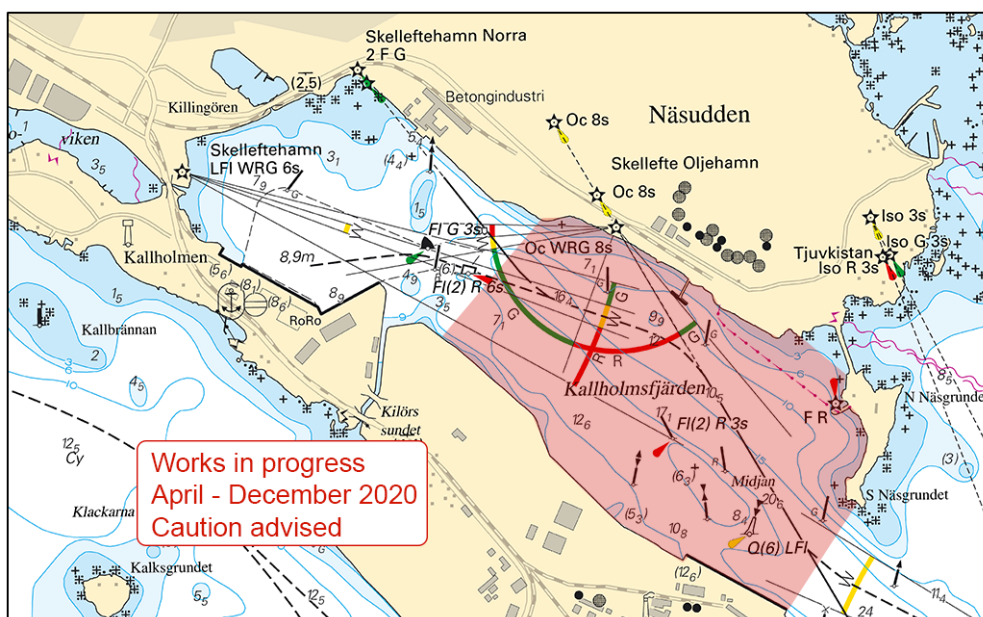

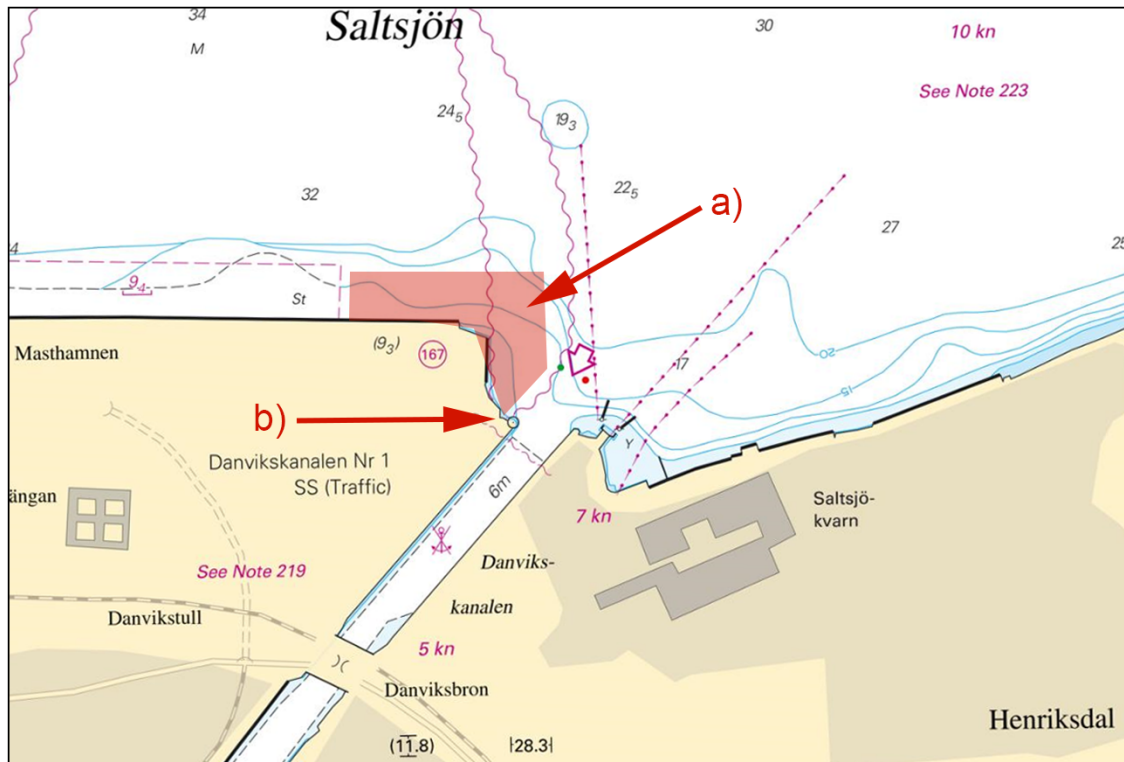
Maintenance work is being performed in the area marked in the chartlet. The public jetty is closed and a temporary mooring point is established.

Passage is expected to change on April 6, according to the chartlet.

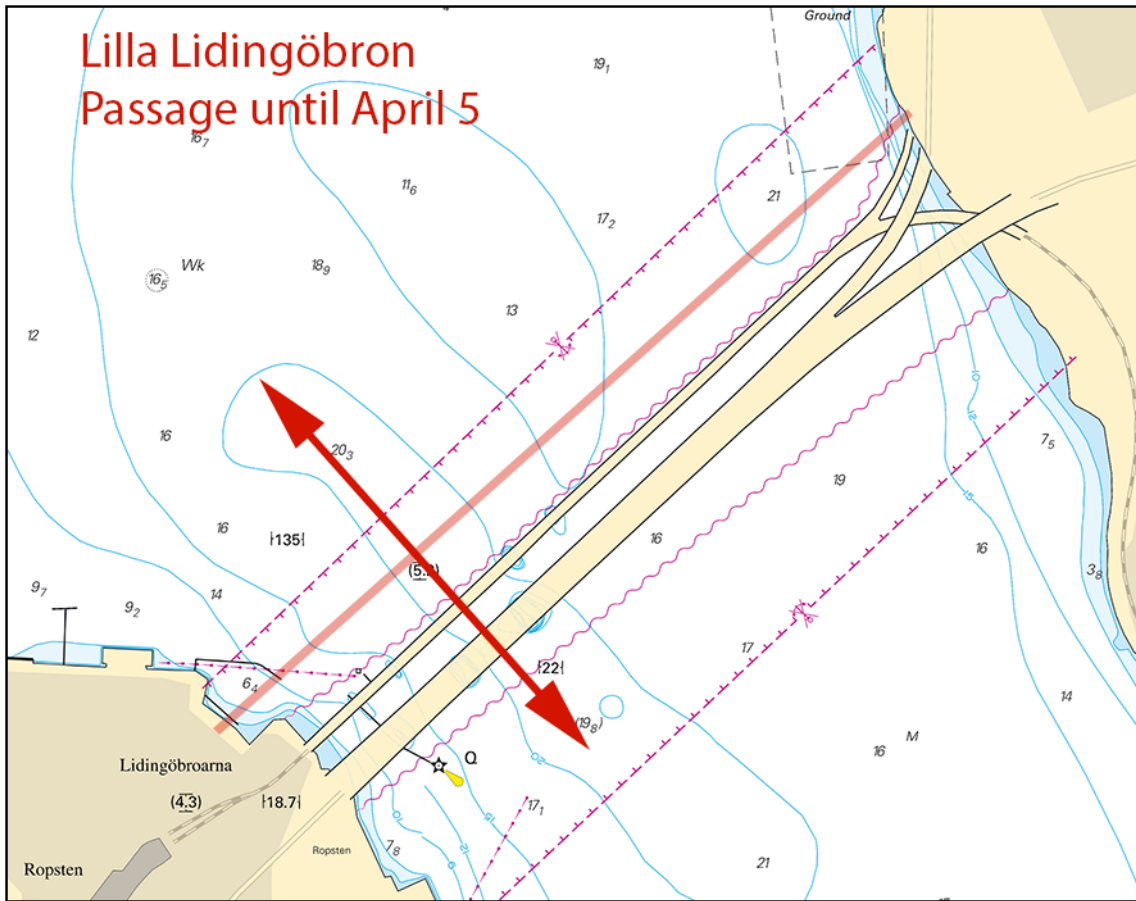
Concreting of new bridge supports takes place in direct connection to the passage.

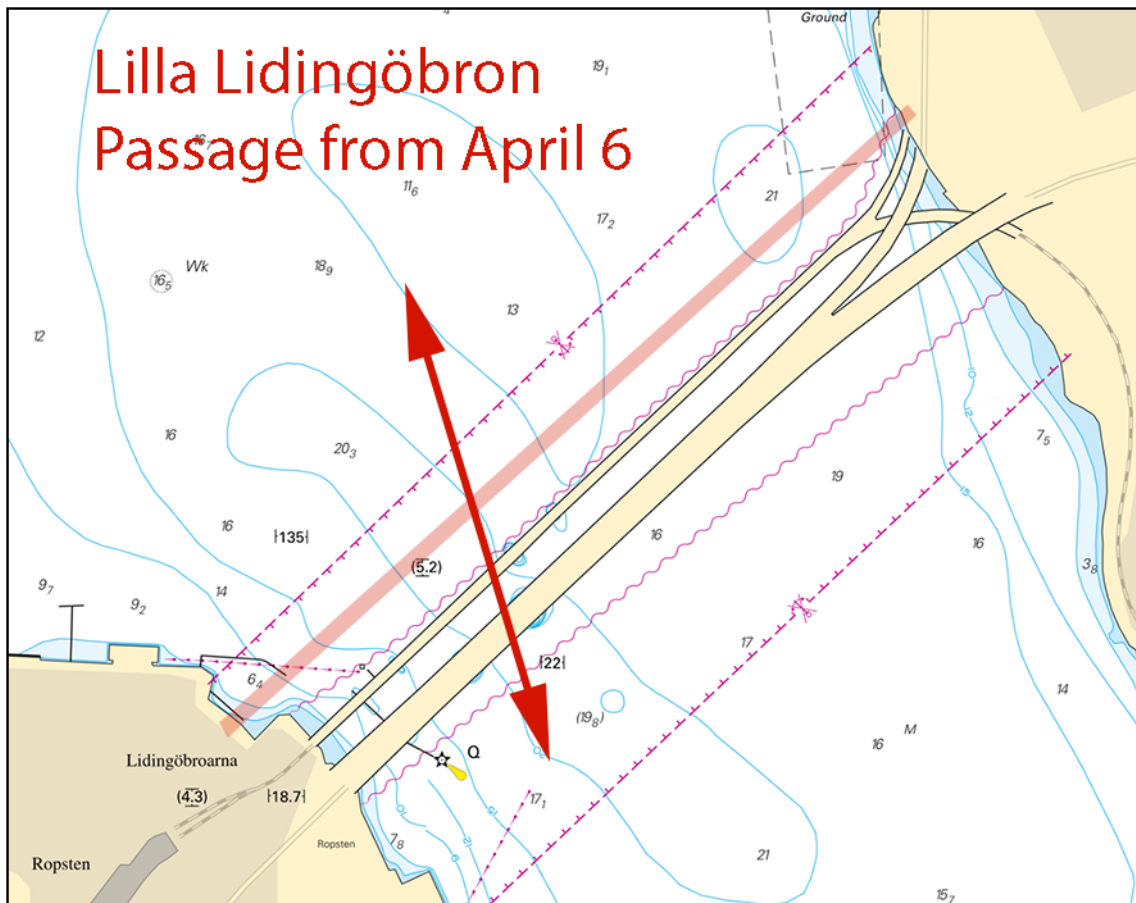

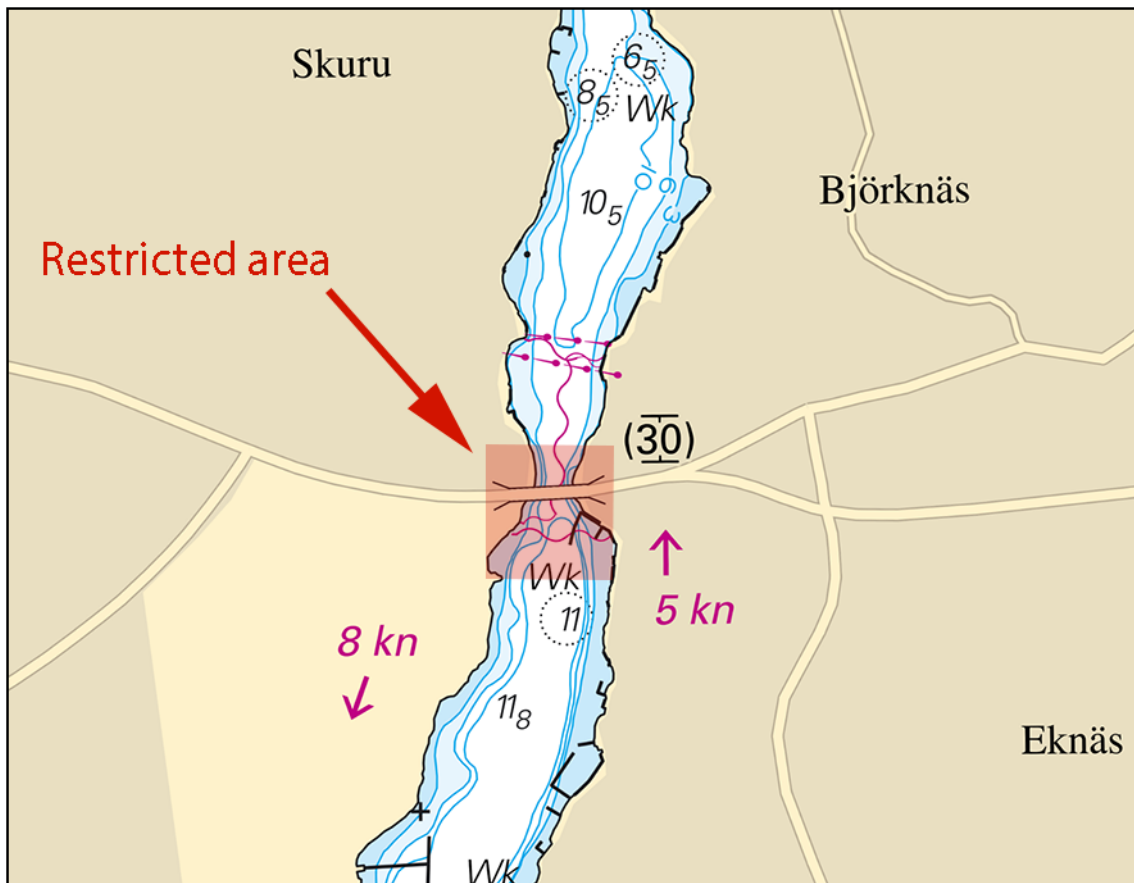

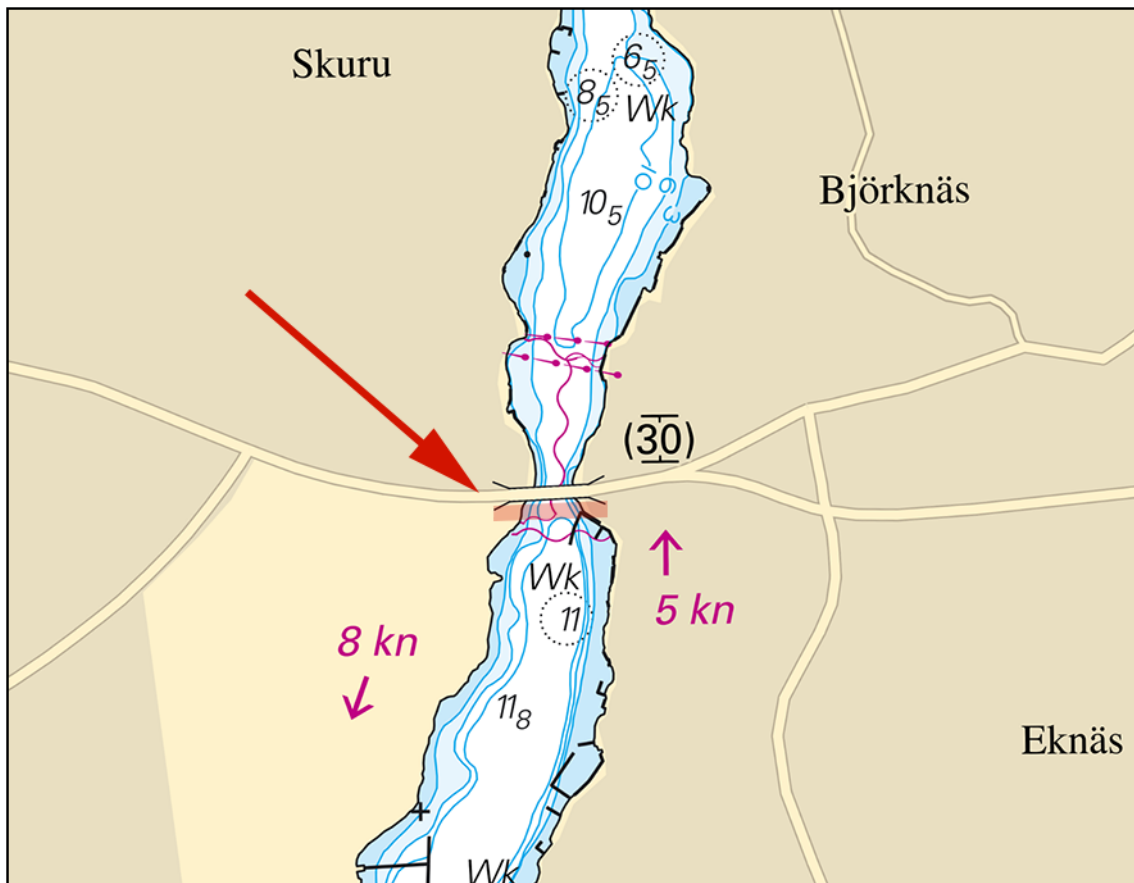
A bridge is being built just south of the existing bridge in Skurusundet.

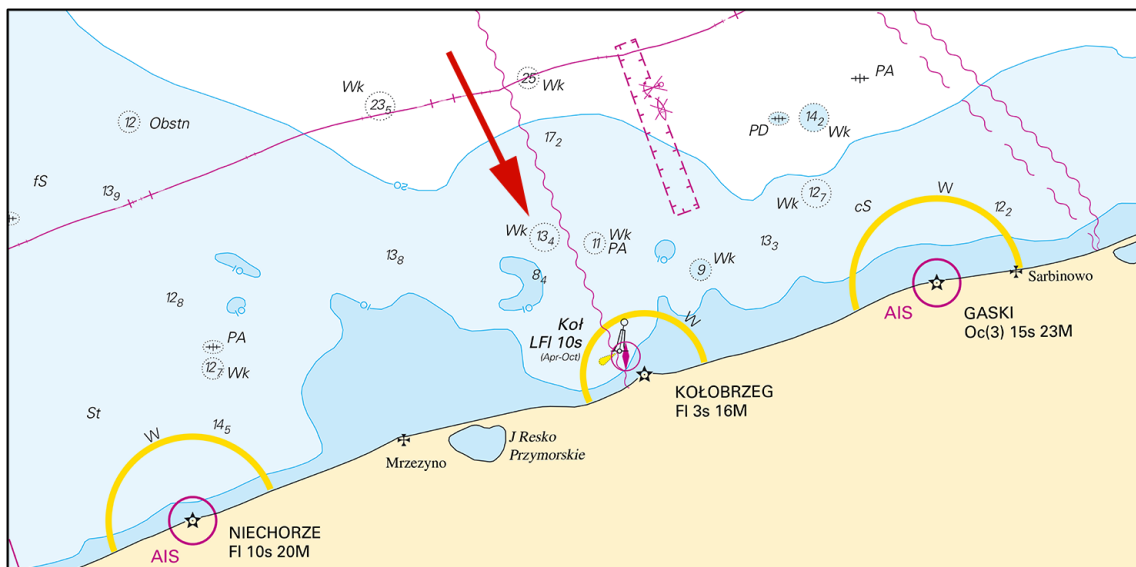

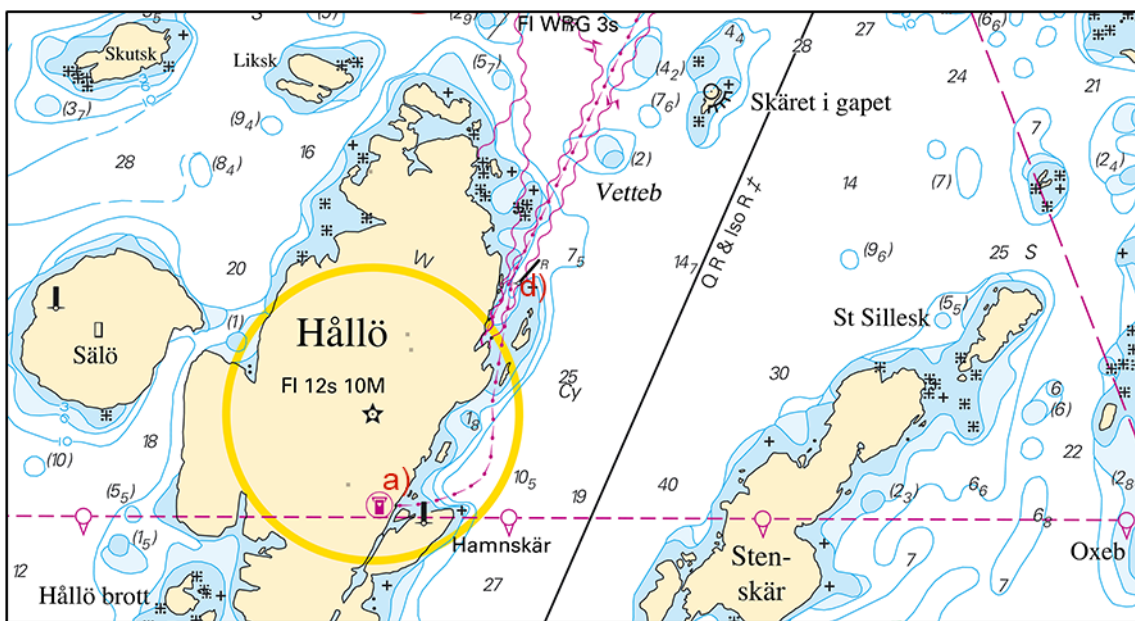

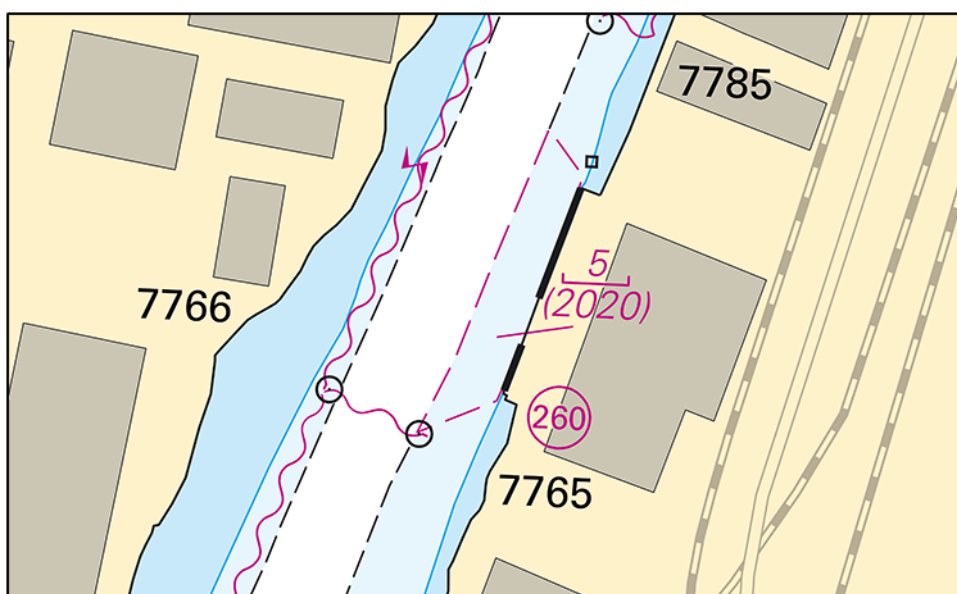
